Purpose of the Programme

The aim of the Social Work study programme is to prepare highly qualified social workers who are able to work innovatively in different professional or academic areas of social work and to apply theories based on the findings of international research and innovative methods of social work practice. They will be familiar with interventions and be able to assess them in a professional context. Graduates will also be able to initiate and implement the research of social work and innovative social programmes, to develop services and affect national and international social policy. Upon the completion of studies, they will be awarded a Master of Social Work qualifying degree.

Learning outcomes

Upon completion of the Social Work graduate studies programme, students will be able to:

- Systemise the theoretical approaches on changing and perspectives of social work theories in particular taking account of critical and social constructionism paradigms; to substantiate the application of innovative methods and interventions of social work practice in different professional contexts as well as the development of new social services and programmes.
- To design and perform applied and comparative scientific studies of social work practice and its context; to substantiate decisions with evidence, to create conditions for the introduction and management of innovations on the micro-, mezzo- and macro levels, and to implement human rights and social equity.
- 3. To implement research projects (analytical studies) revealing the prospects for service beneficiaries, encompassing the creation of qualitative methods of research and knowledge of the sphere of social work and adequate employment of methods and interventions of professional activities.
- 4. To substantiate the appropriateness (fitness for purpose) and effectiveness of intervention while building an ethical interaction between the social worker and customer that promotes change, using special methods for working with an individual, family and/or group in unpredictable complex situations with consideration to the resources and possibilities.

- 5. To initiate the establishment and development of projects, programmes and/or organisations of innovative social services integrating empowering and innovative principles and methods of organisation management and interdisciplinary cooperation, providing for (using) local, national and international financial, human and structural resources.
- 6. To summarise the findings of analysis of the links between policy, resources and social structures when preparing recommendations for the improvement of social policy, development of the social service system and sustainable social development from the side of comparative social policy.
- 7. To link and reasonably convey professional information when communicating and cooperating with social work specialists, service recipients and representatives of other professions; to present actual issues of professional and academic domains of social work in an ethical and responsible manner.
- 8. To critically assess one's own further self-sufficient learning and application of innovative professional knowledge and research methods of social work; to reflect on one's own professional and learning experience and its impact on social welfare.

Career opportunities

Graduates of the Social Work graduate studies programme organise and run social work activities, carry out social work research, implement prevention programmes, administer, develop and implement national and international projects and programmes, initiate new social services, participate in preparation and qualification programmes of social workers, and plan, implement and assess intervention processes for working with an individual, family, group or community in the following institutions:

- Ministry of Social Security and Labour and its divisions; social welfare divisions of municipalities; residential and non-residential establishments providing social services (social service centres, foster homes, special care institutions, day centres and community centres etc.);
- Institutions of the education system: universities, non-university higher schools, institutions of vocational and other training;

- Institutions of the health care system: outpatient and inpatient health care institutions (including mental health) of primary, secondary and tertiary level, addiction centres and public health care institutions;
- Law enforcement institutions: institutions subordinate to the Prison Department;
- National and international non-governmental organisations.

Graduates of the study programme may continue their studies in doctoral study programmes in social work, sociology, educology and other study programmes of social sciences in universities in Lithuania and abroad.

Final assessment

The studies are concluded by preparing and defending a Master's thesis.

Admission requirements

Students are required to have a Bachelor's degree in Social Work. Individuals with a Bachelor's degree in other fields of social and humanitarian studies, those who have an equivalent university education in these fields or hold a Professional Bachelor's degree in Social Work are admitted only subject to the fulfilment of supplementary study requirements.

Supplementary studies

Individuals who hold a Bachelor's degree in fields other than Social Work must have studied the subjects of other social sciences (8 credits), humanitarian sciences (6 credits) and social work (8 credits) and performed Social Work practice of at least 10 credits. Those who have not studied Social Work subjects are proposed the following: Fundamentals of Social Work (4 credits) and Practice of Social Work Skills (4 credits). These subjects are to be studied together with Bachelor study students during the first two semesters of the Master study programme.

Those who have completed the programmes of Social Work field in colleges and acquired a Professional Bachelor's degree are offered a programme of supplementary studies (40 credits). This includes university subjects compulsory for everyone (6 credits), introductory subjects of various fields and areas (15 credits) and Social Work subjects (19 credits).
